Report incidents of injury/emergency & organize training requirements for all site/ project personnel. Inspection of all scaffold ladders, all plants, tools & machinery. Effectively handle, train and motivate project staff to monitor Loss Prevention Program. Initiate comprehensive and speedy procedures for safety reposts. Ensure and Implement all safety procedures are followed. Ensure that all employees are aware of Clients safety requirement.

**Overall Responsibility:** General Civil Mechanical Responsibilities- Identification of potential hazardous area for critical inspection. Conduct job safety induction and toolbox meeting. Monitor General House |Keeping. Instruct of specific and right Personal Protective Equipment (PPE) related to the job. Prepare Accident/Investigation Report. Issue work permit and check work area before start of work. Ensure safe work in confined space (Safety watch, Entry Permit, Rescue arrangement etc.) Ensure safe working at heights, check of lifting tools/Machines, and Check scaffolding and PTW (red tag/green tag). Ensure excavation safety (Benching and Shoring) and safe work procedure, Job safety Analysis, Checking unsafe condition, Coordinating safety meetings, Daily safety site inspection and giving solution through (3 Es)- Engineering, Education and Enforcement.

**Fire Safety:** Monitor Hot Jobs, flammable substances and firefighting. Identify Classes of fires and application of suitable firefighting system like smothering (Blanketing), Cooling, Starvation and fire extinguisher inspection.

**Electrical Safety Responsibilities:** daily inspection of electrical cords, connections and electrical system. Ensure Earthling/grounding and other safety devices. Carry out induction of new workers and specific PPE, for electrical workers.

**Reports & Permits Responsibilities:** Daily safety observation report prepare Accident/Incident investigation reports, monthly plant inspection reports and Violation report. Issues Hot work permit to work in confined space and permit for working at heights. Issues permit for LOTO.
