

 - Use personal protective equipment and engineering controls (e.g., fume hoods) appropriate to the work.
 - Curtail or stop their work if they reasonably believe continuation of the work poses an imminent danger to health or safety, and immediately notify a supervisor in the chain of authority over the work.
 - Report all unsafe conditions to the Manager or safety committee as soon as is reasonably possible.
 - Worked on projects and experienced various activities such as Hot works (welding, cutting & grinding) Lifting, Road Safety, Traffic Management and pedestrians route, Electrical & Instrumentation, scaffolding, Civil works including Deep Excavations, concreting, buildings, grouting, piling and earthworks.
 - Attend pre-job, planning and client meetings as required on HSE related matters.
 - Ensure training, tool box meetings, and drills are implemented as part of the company's training and HSE program, i.e. emergency response systems, etc.
 - Investigate and complete the process for close out of all Accident /Incident Investigation, near miss Reports and prepare/submit lessons learned to the Regional HSE Manager for promulgation to the management.
