- Conducting scheduled employee safety training classes in emergency response, evacuations, fire extinguishers, heavy equipment, and other operations. and respond to employee injuries and administered first aid as needed for cuts and bleeding, and back injuries from improper lifting techniques.
- Performed daily walk-through for safety inspections of the facilities including fire systems. Documented and photographed findings and compiled and presented statistical data on safety activities to EH&S Director. Coordinate in installation of fire extinguishers where necessary.
- Participate in Investigation of accidents and injuries. Documented the injuries; detailed the events leading to, during, and after the accident; and made recommendations to fix hazards.
- To prepare toolbox meeting topics, conduct weekly toolbox meeting by using topic affective safety, welfare, and environment. Investigate, determine and report of any accident, incident and near miss and recommend action to be taken to prevent its recurrence.
