- Perform daily safety inspection through LSI\_ Life Safety Inspection.
  - Perform and conduct daily safety observation.
  - Preparing and update CS Contractor Safety Program Assessment Checklist/Document and participate in Safety Audit.
  - Preparing and update Contractor VSP\_ Vehicle Safety Program / Document and participate Safety Audit.
  - Empowered by the Management to Stop their own work and work related to the contract that they deem to be unsafe and take immediate corrective actions.
  - Communicate Safety Rules and Standards to IKK All workforce.
  - Inspect the Work Site daily, report any unsafe acts/conditions to the Supervisor and/or Foreman, provide recommendations to correct deficiencies and follow-up to ensure corrective actions have been taken.
  - Participate in incident investigations, Safety Meetings, Drills, etc., and conduct/Facilitate Safety Training sessions.
  - Ensure Field Compliance of All sites with respect to Saudi Aramco Safety Rules and Regulations.

- Follow the Instructions given by HSE Manager related to Safety.
  - Review work methods and precautions with site supervision before work starts.

- Immediately report all incidents and near misses to the SAPO\_ Saudi Aramco proponent organization.
- Ensure incidents and near misses are properly investigated to determine root causes, make recommendations to prevent recurrence and that corrective actions have been taken.
- Ensure Field Compliance of All Sites with respect to Saudi Aramco Safety Rules & Regulations.
- Conduct/Facilitate In-house Safety Orientation to all new employee before deployment at the work site.
- Submit the contractor Monthly Training Matrix using Saudi Aramco CS EQIP Training form to the Division Safety Coordinator every end of the month as part of the monthly safety compliance report.
- Report direct all the employee training record to Company Safety Manager & Department/Project Manager.
- Ensure that Job Safety Analysis(JSA), & Hazard Identification Plan(HIP), & Contractor Site Safety Plan (CSSP) is understood and implement required for the Project.
- Ensure that Saudi Aramco Schedule "D" (Health and Safety Requirements) as a contract including SACSM\_ Saudi Aramco Construction Safety Manual is understood and implement required for the Project.
- Support Project and site/facility management in fulfilling their environmental Health and Safety Responsibilities.
- Coordinate the Project EH&S effort with the company and client requirement.
- Maintaining current knowledge of SACSM, SASC standard, client safety standard and company safety standard.
- Administers project EH&S policies and procedure with focus on potentially hazardous operations and emphasizing proactive solution.
- Communicate to project management and division managers the progress of the project safety program.
- Participates in formal weekly EH&S inspection program with a document report reflecting safety discrepancies and recommendations for appropriate corrective actions by the responsible party.
- Attends and provides safety input into weekly supervisor's safety meeting.
- Administers the project environmental health and safety program.
- Evaluates and distributes project incident reports health and safety reports and records of achievement to the site project manager.
- Assists in the investigation of all accidents injuries / illness fire property damage and other related incidents and issues reports as required.
- Enforce company site safety rules and regulations inside the worksite.
- Participate in weekly safety audit together with all members of safety committee.
- Ensure that all firefighting equipment are in excellent condition at all times.
- Provide advice and counsel to all employees regarding compliance with site safety requirements of the project.
- Preparation of safety statistics and updating of project safety information board.
- Supervised the preparation of various safety signs and installation of safety barricades as required inside the worksite.
- Conducting safety inspection of lifting gears, portable power tools and hand tools on monthly basis.
- Monitoring critical activities such as hot work, lifting operation, excavation, scaffold erection, demolition etc.
